## Bothered by Telemarketing Calls?

You can reduce the number of unwanted sales calls you receive by signing up with the National and Indiana Do-Not-Call registries. It's FREE! Most legitimate companies don't call your number once it has been on the registry for 31 days. If a company is ignoring the Registry, there's a good chance that it's a scam. If you get these calls, hang up and file a complaint with the FTC and Indiana's Telephone Privacy division of the Attorney General's office.

## Public Notice

Southeastern Indiana Rural Telephone Cooperative, Inc. ("SIRTC") provides voice telephony service throughout its cooperative designated serving area, including minutes of use for local service provided at no additional charge; access to emergency services provided by local government or other public safety organizations, such as 911 and enhanced 911, to the extent the local government in SIRTC's service area has implemented 911 or enhanced 911 systems; and toll limitation for qualifying low-income consumers. Basic services monthly rates: (\$17.45)\* single party residential line; (\$15.25-\$18.60)\* multi and single party business lines; (\$6.50-\$9.20) single and multi-party federal subscriber line charge. \*The rates do not include charges for long distance, operator services, directory assistance, 911 emergency services, or other taxes, fees and surcharges. Discounts are available to low-income customers who qualify for Lifeline, a government assistance program that is non-transferable and limited to one discount per household. ## Lifeline Assistance

Lifeline Assistance lowers the cost of basic monthly local telephone service. Eligible consumers can receive \$9.25 per month in discounts.

**You are eligible if someone in your household participates in one of the following programs:**

- Household income at or below 135% of the federal poverty guidelines (see chart to the right)\*
- Federal Veterans Pension
- Federal Public Housing Assistance or Section 8
- Medicaid
- Food Stamps
- Supplemental Security Income (SSI) **Not to be confused with Social Security Income**

**\*2017 Estimated Income Requirements for a Household at or Below 135% of the Federal Poverty Guidelines.**

\*For each additional person, add \$5,643

Lifeline is a government assistance program, the service is non-transferable, only eligible consumers may enroll in the program, and the program is limited to one discount per household. Lifeline customers must verify continued eligibility by the customer's anniversary date on a rolling 12-month basis. Customers are required to remain with their service provider for a minimum period of 60 days (voice) or 12 months (broadband) before they can switch their benefit to a different provider.
